PURPOSE OF THE COMMITTEE

The voters of the Fountain Valley School District approved a \$63 million bond measure with 63.2% YES vote on November 8, 2016. The proceeds of the bonds are intended to be used to repair and modernize aging classrooms and school facilities, including repairing deteriorating roofs, plumbing, electrical and air conditioning systems; upgrade classrooms, science labs, libraries, facilities and technology that support student achievement in reading, math, arts, science, and technology; and improve student safety and campus security.

As set forth in Prop 39, the purpose of the Measure O Citizens' Bond Oversight Committee ("CBOC") is to review and report on the proper expenditure of taxpayers' money for school construction on the Measure O bond projects.

COMMITTEE'S ACTIVITIES

For Fiscal Year 2019/2020, the CBOC conducted quarterly meetings which included review of facilities projects and project expenditures. Some of these meetings were held at District school sites to familiarize the CBOC with Measure O project construction progress:

August 19, 2019, Masuda Middle School December 9, 2019, Tamura Elementary School March 2, 2020, Cox Elementary School

In accordance with the provisions of the Ralph M. Brown Public Act, the committee conducts meetings for the public's attendance and participation. Meeting agendas and notices are sent to committee members and posted within the required period of time. Notices are posted at the Fountain Valley School District's Office and the District's website. Meeting notices, agenda, minutes, and all other documents received by the committee are a matter of public record and are available on the Fountain Valley School District's website.

District Staff presented financial reports, communications, project, and program updates at each meeting of the CBOC. Handouts were distributed at the meetings and subsequently posted to the District's Measure O CBOC web page.

AUDIT FINDINGS

In addition, on March 2, 2020, the CBOC received the annual Financial and Performance Audit reports for the 2018/2019 Fiscal Year. There were no findings reported for the Measure O financial statements. It was also concluded that the District properly accounted for the expenditures in the building fund and expenditures were made for authorized Bond projects.


As was shared in a previous annual report, the first phase of the Measure O project, Courreges Elementary School and Masuda Middle School was completed in the summer of 2019.

The second phase of construction included Cox Elementary, Tamura Elementary and Fulton Middle School. Plans were approved for these schools in the winter of 2018/2019 and work began in summer of 2019.


Cox Elementary School: The installation of HVAC and modernization work are complete and all teachers have moved back into their classrooms. Final work will be complete by the end of summer.



Tamura Elementary School: Modernization, roofing and HVA installation is complete at Cox Elementary as well. Final work on the main parking lot was completed in August 2020.



Fulton Middle School: The HVAC installation, roof replacement, and classroom upgrades are complete and the last group of teachers have moved back into their rooms. Work on the portables will be completed at the end of the summer 2020.



Phase 3 schools, Gisler Elementary and Talbert Middle School began construction in June of 2020. Work is progressing well and is expected to be completed in the summer of 2021. Work on Phase 4 schools, Newland Elementary School and Oka Elementary School is scheduled to begin in the summer of 2021. Plans for Newland have been approved by DSA, while the plans for Oka plans have been submitted and are awaiting approval.

COMMITTEE'S CONCLUSION

The Measure O Citizens' Bond Oversight Committee is pleased to inform the public, and the Fountain Valley School District Board of Trustees, that, as in the previous two years, the District continues to be in compliance with Article XIIIA, section 1(b)(3) of the California Constitution. The current projects are authorized under Measure O and bond proceeds have been expended in accordance with the ballot measure. STAFF REPORTS AND PRESENTATIONS

Assistant Superintendent, Educational Services, Dr. Steve McLaughlin provided a review for the Board of Trustees on the selection process and recommended online curriculum to support remote/virtual learning for the 2020-21 school year. He provided an overview of Distance Learning from spring 2020, California's expectations for learning for the 2020-21 school year as well as expectations for distance learning for 2020-21 school year. In addition, he shared an overview of results from the August parent survey. He shared our District plan for staying connected while in distance or Virtual/Remote Learning. He reviewed the supplemental online curriculum selection process and provided an REPORT ON THE RECOMMENED ONLINE CURRICULUM FOR THE 2020/21 SCHOOL YEAR

PLEDGE OF ALLEGIANCE overview of Florida Virtual Schools (FLVS). In closing, he shared next steps with the Board including professional development, collaboration and improving each day.

Assistant Superintendent, Business, Christine Fullerton and Director, Fiscal Services, Isidro Guerra provided a report for the Board of Trustees on the 45-day revision to the 2020-21 District Budget. Education Code 42127(h) requires districts to approve necessary budget revisions to reflect funding made available by the Budget Act. The 45-day revision is due August 13th. Mrs. Fullerton shared the budget assumptions that the 2020-21 was built on in June. She shared the changes to these assumptions based upon the Budget Act. Following this, Mr. Guerra shared updates to LCFF, including the ADA hold harmless provision that does not give credit for increases in ADA. In addition, flat funding or 0% COLA increases are expected for several years. He reviewed additional revenues, all one-time funds specifically for COVID-19-related activities. Mr. Guerra also reviewed General Fund revenues and expenses. In closing, Mrs. Fullerton shared the continued uncertainty as COVID-19 response and preparedness anticipated expenditures are not reflected in the 45-day revision due to their uncertain nature and timing. In addition, uncertainty exists surrounding the length and depth of the recession, the possibility of an additional Federal stimulus and State funding in 2021-22 and beyond. She shared next steps with the Board including Unaudited Actuals in September and First Interim in December.

BOARD REPORTS AND COMMUNICATIONS

Mr. Collins' activities since the last meeting included: several webinars and zoom in addition to extensive reading related to the reopening of schools. He encouraged everyone to continue wearing their masks, social distancing and washing hands.

Mrs. Crandall thanked senior staff for the great amount of work that went into their presentations this evening. Her activities since the last meeting included: tour of Fulton to see completed Measure O work; funeral of former Fountain Valley Council Member John Collins; virtual meeting with FV Police Chief Matt Sheppard; 11 virtual opportunities including: 5 hosted by CSBA with topics from budget to reopening, legal issues and distance learning, 2 hosted by OCSBA including a fiscal webinar with Capitol Advisors, and 1 hosted by Truth in Accounting; conference call with US Secretary of Education, Betsy DeVos, US Surgeon General, Jerome Adams and US Assistant General, Department of

REPORT ON THE 45-DAY REVISION TO 2020-21 DISTRICT BUDGET

Justice, Jennifer Hickey as they spoke about schools; watched live news conference of Governor Newsom on July 17; and continued reading and listening regarding our current situation in order to make informed decisions on behalf of our students, staff and community.

Mrs. Schultz' activities since the last meeting included: tour of Fulton to see completed Measure O work and she continues, through her job, to hear of college students going back to school out of state. She noted that some students are getting back to normal activities at the college level.

Mr. Cunneen's activities since the last meeting included: tour of Fulton to see completed Measure O work. In addition, he thanked those apart of the Reopening Schools Advisory and senior staff as they continue to prepare and plan to safely reopen schools.

Mrs. Galindo thanked staff for their flexibility as we continue to move forward toward safely reopening schools. She noted the difficulties in working in the world at this time. She thanked her fellow Trustees for their service this month.

STAFF REPORTS AND PRESENTATIONS

Superintendent, Mark Johnson, Ed.D., and Assistant Superintendent, Educational Services, Steve McLaughlin, Ed.D., presented for the Board of Trustees, lead discussion and provided updates regarding reopening schools. Dr. Johnson began by reviewing the recent events regarding guidance for reopening schools including the Governor's July 17th press conference and CA's Pandemic Plan for Schools presented at this press conference. He shared current Orange County rates regarding positive cases and hospitalizations. He also shared the work of the Reopening Schools Advisory and the reopening schools plan approved by the Board of Trustees at the August 6th meeting. Following this, he shared additional information shared on August 3rd from the Governor's office. At the August 17th press conference it was shared that the data is now accurate with 42 of 58 counties on the watch list. Following this, he reviewed the instructional models shared in the Reopening Plan and approved by the Board. He noted that regarding hybrid models, AM/PM model will be all virtual on Mondays if the hybrid model is selected. Following this, Dr. McLaughlin reviewed the full virtual/remote model for middle school students. In addition, he reviewed the full virtual schedule for elementary students, TK-5th. Dr. McLaughlin reviewed the middle school hybrid option, rotating days; as well as the elementary hybrid option, AM/PM, noting the proposed update for all students to be all remote on Mondays. In addition, Dr. Johnson shared that the District will be sharing whether or not the school year will start in person for

Moreover, of the two hybrid options presented for elementary students, he noted senior staff's recommendation for the Board that elementary students return in an AM/PM hybrid model for TK-5th grade students (4 days a week/one day virtual). Following discussion, the Board reached consensus that when it is safe to return to in-person instruction, those that selected the in-person instructional model will return in a hybrid setting. For elementary students, this will be an AM/PM hybrid and for middle school students this will be a rotating days schedule.

Background:

Per Education Code Sections 1629 and 42132, each year governing boards shall adopt a resolution identifying their estimated appropriations limits for the current year and their actual appropriations limit for the prior year. The appropriations limit is the dollar amount that a District can expend in one fiscal year and is limited to the percentage increase in the cost of living and the percentage increase in the state or local government's population. The District did not exceed its appropriation limit of \$37.41 million for 2019-20. The estimated appropriation limit for 2020-21 is \$38.81 million. The calculation of the appropriation limit is available for public review in the Business Services Office.

Recommendation:

It is recommended that the Governing Board adopt **RESOLUTION 2021-06**, identifying the 2019-20 actual appropriation limit and the 2020-21 estimated appropriation limit.

RESOLUTION 2021-06 GANN AMENDMENT APPROPRIATIONS LIMIT

WHEREAS, in November of 1979, the California electorate did adopt Proposition 4, commonly called the Gann Amendment, which added Article XIII-B to the California Constitution; and,

WHEREAS, the provisions of that Article establish maximum appropriation limitations, commonly called "Gann Limits," for public agencies, including school districts; and,

WHEREAS, the District must establish a revised Gann limit for the 2019-20 fiscal year and a projected Gann Limit for the 2020-21 fiscal year in accordance with the provisions of Article XIII-B and applicable statutory law;

NOW, THEREFORE, BE IT RESOLVED that this Board does provide public notice that the attached calculations and documentation of the Gann limits for the 2019-20 and 2020-21 fiscal years are made in accord with applicable constitutional and statutory law;

AND BE IT FURTHER RESOLVED that this Board does hereby declare that the appropriations in the Budget for the 2019-20 and 2020-21 fiscal years do not exceed the limitations imposed by Proposition 4;

AND BE IT FURTHER RESOLVED that the Superintendent provides copies of this resolution along with the appropriate attachments to interested citizens of this district.

Background:

Effective January 1, 1997, Senate Bill 1693 amended Government Code Sections 66001 and 66006 to impose more detailed reporting requirements for developer fees. SB 1693 amended Section 66006(b) to provide the following revised reporting requirement:

Section 66006 (b)(1)

For each separate account or fund established pursuant to subdivision (a), the local agency shall, within 180 days after the last day of each fiscal year, make available to the public the following information for the fiscal year:"

(1) A brief description of the type of fee in the account or fund.

- (2) The amount of the fee.
- (3) The beginning and ending balance of the account or fund.
- (4) The amount of the fees collected and the interest earned.

Government Code Section 66006 also requires the local agency to review this fund at a regularly scheduled public meeting.

Attached are worksheets summarizing the fees collected, interest earned and specific expenditures on projects during fiscal year 2019-20 as required under section 66006(b)(1).

Recommendation:

It is recommended that the Board of Trustees accepts the report on the use of the Capital Facilities Fund income and expenditures.

Background:

At unaudited actuals, the District compares actual results for the fiscal year ending June 30, 2020 to the estimated actuals presented at budget adoption. The total general fund ending balance is \$21.3 million, of which \$11.2 million is restricted and/or assigned.

The District has met all of the requirements outlined in AB1200 and all of the District's funds reflect a positive ending balance.

The 2020-21 adopted budget has been adjusted to reflect changes in revenue assumptions outlined in the 45-Day Budget Revision as well as expenditure of all COVID-19 relief funds. Beginning Fund Balances have also been adjusted to reflect revisions to the 2019-20 ending fund balance. Additional increases/decreases in revenue and expenditures affecting the budget are addressed throughout the year, with the next major revision to be detailed in the first interim report in December 2020.

Recommendation:

It is recommended that the Board of Trustees approves the unaudited actuals for fiscal year 2019-20 and the adjusted 2020-21 budget.
