Background:

As outlined in Board Policy and Administrative Regulation 6161.1(a), *Selection and Evaluation of Instructional Materials*, the process of selecting new materials to support district-wide curriculum and instruction is critical to ensuring all students have access to rigorous and differentiated curriculum.

As a result of legislative action, the State Board of Education (SBE) approved a list of English Language Arts/English Language Development materials based on the State's frameworks and related criteria. Beginning in February 2022, a dedicated team of FVSD teachers has engaged in a comprehensive process of reviewing resources approved by the State Department of Education. Under the leadership of Page Hertzberg, FVSD's Teacher on Special Assignment, and working in partnership with the Orange County Department of Education, FVSD's Instructional Materials Review Team (1) reviewed data from a survey distributed to all FVSD ELA/ELD teachers, (2) reviewed "best practices" in literacy instruction, (3) reviewed the CA Framework for English Language Arts/English Language Development, English Language Arts/Literacy and English Language Development Adoption Toolkit, and Guidelines for Piloting Textbooks and Instructional Materials, and (4) developed an FVSD-specific lens/grade level priorities for evaluating available state-approved resources. Areas of focus for the district lens included:

1. **Writing-** Argument writing that requires students to develop claims and support them with reasons and evidence; Researching & analyzing sources; and, Revising and editing
2. **Speaking & Listening-** Structured listening lessons with resources provided
3. **Language-** Academic vocabulary; Grammar lessons integrated into reading and writing lessons
4. **ELD Support-** Integrated support for all levels of English learners; Support in scope and sequence of instruction for all English Learners
5. **Reading-** Synthesizing sources with deep analysis; Texts and authors that are culturally relevant and representative of our students; Integrated support for struggling and advanced learners
6. **Universal Access-** Integrates supports for students reading below grade level, students with IEPs, English learners, and Advanced/GATE students
7. **Materials-** A balance of consumable and digital resources

Current Consideration:

Using the District lens, the Instructional Materials review team identified two programs for trial/pilot during the 2022-23 school year, (1) Houghton Mifflin Harcourt's program, CA Collections 2017, and (2) McGraw-Hill's program, StudySync 2017, both from the approved list of curricula from SBE. During the 2022-23 school year, middle school English Language Arts/English Language Development teachers were trained in both programs and we are pleased to share that 18 teachers participated in the piloting process. The pilot of the HMH CA Collections program began in October and concluded in mid-November, while the pilot of the MH StudySync program began in February and concluded in mid-March. At the conclusion of both pilot windows, an input survey was conducted with both teachers and students to gather feedback regarding the programs. The Instructional Materials Review Team met on April 20, 2023, to review the results of the surveys, share observations, engage in discussions, and arrive at a consensus. After completing this comprehensive review process, the Instructional Materials Review Team is recommending McGraw-Hill's StudySync program for adoption.

The Ed Services Team has worked in partnership with Elevo, Inc.s leadership team to develop a customized program that, if approved by the FVSD Board of Trustees, would continue to provide sports and wellness-related activities each week at all seven school sites as part of the ELOP program.
