STAFF REPORTS AND PRESENTATIONS

Assistant Superintendent Paul Burkart presented information to the board on the State budget, the District budget and the use of the Federal Stimulus funds. He explained the current 18.5% deficit and that the deficit factor will likely increase in 2010-11. He explained that historically, it has taken 2-3 years for a return to prerecession level from a recession. Going forward, either further reductions must be found or deficit spending will

continue. He noted that the Second Interim report will be available at the December 10th meeting. He explained that in December, the district will begin to develop the budget for 2010-11 and in January a more detailed calendar will be available. His presentation emphasized that while 2009-10 is a difficult year, 2010-11 will prove to be even harder.

Mr. Collins noted that he has known Mrs. Weiss for a while and she has served in so many capacities in the district. He explained that she is not just a mom, but also PTA president at Courreges School, a member of SPC, ACE, the Sacramento Safari, and the 4th District Council. He explained that he sees Mrs. Weiss as a fine person and one that would represent the district in a fair and open manner.

Mrs. Edwards agreed that Mrs. Weiss would bring strength to the board, especially given that she has a business background that the board currently does not seem to have.

Mrs. Allcorn noted that it is a complement to the district that ten candidates answered the call when needed. She explained that the role is not for pay and not easy, but an important one. She noted that one of Mrs. Weiss' assets is that she is a parent. She explained that sometimes it is not easy to walk on campus and have to eliminate 20:1, but noted what credibility being a parent also has when others know that your children are directly impacted by decisions. She said that it would be terrific to have someone there on the front line with this experience.

Mr. McCombs noted those outstanding candidates and their

experience in the district and love for education. He noted that these candidates are advocates for the public education of all children and have the skills to be effective and noted that Mrs. Weiss is one of these candidates, are Mrs. Crandall and Dr. Sussman. He stated that he could support all three. He explained that this is a difficult decision.

Mrs. Allcorn Noted that in the district where she is subbing, a

budget bulletin is put out to the parents. She said that she is not sure if the district needs to send more paper home with students, but that this is interesting and maybe as the district trudges through this it is something to consider

in the future.

Mr. McCombs Congratulated and welcomed Mrs. Weiss. He

noted that it is great having a parent with children in the district, in addition to Mrs. Allcorn. He also noted the difficulty in doing something in front of the community, like interviewing, which is normally done in private

in private enterprise.

Dr. Ecker Again congratulated Mrs. Weiss and stated that

he was reminded of all that she has contributed including not only attending the public hearings

on the budget this year, but also being

instrumental in planning and providing the idea for the sessions. In light of the 20:1 program reduction, Mrs. Weiss was instrumental in setting the groundwork for the Parent Community Volunteer Academy.

Dr. Ecker

Thanked all of the individuals that applied. He joined the board in their deep appreciation and commendation of these individuals. He noted that he was pleasantly surprised to have ten candidates. And that these ten applied not because of they have personal agendas, but because they have an interest in serving 6,000 plus students and that this is commendable and a tribute to the district. He urged those individuals not appointed to stay involved as there are many opportunities in the future.

Dr. Ecker

Thanked Mr. Burkart for his presentation on the budget and noted that this underscores that as much as 2009-10 has been hard, as the district comes into less money in the budget, 2010-2011 will be even harder. It will take more in the future to preserve the reserve fund and he noted the need more and more to ask individuals for assistance. He noted his hope to begin seeing a turn around and good news in the future.

Thanked Mr. Wood for his presentation and noted that it is teachers like Mr. Wood that do what they do because they love it. He noted that the presentation was just amazing. He expressed his appreciation to Mr. Wood and commended him.

Dr. Ecker

Thanked Mrs. Heather Harrison for coordinating the Masuda Veteran's Day celebration. He noted that it was wonderful that this event reminded young students who do not remember the "Greatest Generation" of true service and sacrifice.

Dr. Ecker

Reminded the audience of the upcoming Taste of Fountain Valley. He noted that this is a great way to support the district and to contribute. He commended the entire Foundation board that has worked so hard to put together the event.
