She noted that at Cox and Moiola there is extensive use of Thinking Maps and was pleased to see how these are used in several different subjects and across grades. She attended the Elementary School Band concert and also stopped in on the Parent Volunteer Academy training at the District with Sandra Crandall. She commended Mrs. Crandall on her work with these volunteers and thanked her for her time with them. She also attended the Lunar New Year celebration at Tamura and the Tamura school play.

Mr. Collins commended the PTA's and PTO's from each school for their generous donations to the District. He noted that the district is blessed to have so many dedicated and generous parents. He noted the wonderful article on Moiola in the *OC Register* covering their Lunar New Year celebration. STAFF REPORTS AND PRESENTATIONS

Assistant Superintendent, Paul Burkart, provided details for the Board of Trustees of the proposed State budget and its impact on the Fountain Valley School District for the next fiscal year and future years. Although he noted that nationally there are good indicators present that the economy is turning around, the State of California is still suffering from very high unemployment and school funding is therefore still effected. He explained the long term effects of our deficit spending and the need for cuts to 2010-11 district budget of about \$3M. He noted that there will be two community meetings to provide information for parents and staff as well as several study sessions for the Board to review and discuss proposed solutions in March and April. He also explained that an email will go out to district staff over the next week or so soliciting ideas for budget cuts and that he will personally read each response.

PRESENTATION ON THE GOVERNOR'S PROPOSED 2010-11 BUDGET (ORAL REPORT)

Mr. McCombs thanked Mr. Burkart for his very informative presentation. He noted that Mr. Burkart always puts together a great presentation.

Mr. Collins asked Mr. Burkart about Federal funding of Special Education and the potential for increase. Mr. Burkart explained that this has not been supported by the State Senate yet and the commitment put out the Governor has never been met.

Dr. Ecker thanked Mr. Burkart for his presentation and explained that this allows us to see the problem. He noted that the district will keep the Board apprised of the progress of the budget committee and in March will present proposed solutions. He noted the idea to schedule a study session for the board in April and also in March.

Mr. Burkart and Dr. Ecker explained that at the March 11th board meeting, dates for the two community meetings will be discussed hopefully having one in the second half of March or the first half of April. Once the dates have been set, they will be communicated to the sites through SPC and on the district web site.

In its continuing goal to maintain a set of current board policies, it is necessary that the Fountain Valley School District update certain regulations due to changes in Education
